HMS COVID Decision Chart

- Red text indicates a need to isolate or quarantine, black text indicates that the child may continue attending school
- A positive case in the last 90 days exempts all close contacts and household contacts from quarantine and test to stay unless currently positive and in isolation
- A person is considered "vaccinated" two weeks after receiving the last shot in their series (must submit proof of vaccination)
- When testing daily, results should be emailed to both admin and Guide
- A negative test to return after quarantine must be either a PCR or two negative antigen taken 12 hours apart.
- A negative test to return after **isolation** must be two negative antigen tests taken 12 hours apart. **NO PCR**.
- Exposure is considered the last day of contact to someone that tests positive for COVID.
- For continuous exposure, last date of contact is 5 days from last family member's positive test PLUS 5 additional days.
- Continuous exposure is when the positive family member is **not** isolating away from the child and they share any home space, including bathrooms.
- In order to be considered non-continuous exposure the positive family member must be completely isolated from the child, either in a separate home or not sharing any household space, including bathrooms. Masking when around the child does not count.
- **Test to Stay:** submit negative test result each morning prior to attending for 5 days from last exposure to last positive contact. Toddlers must test to stay for 10 days from last exposure because they can't mask.
